100 days Campaign - "Saksham Niveshak": July 28, 2025 to November 6, 2025 Update Your KYC Details and Claim Your Unpaid/Unclaimed Dividends and Shares

The Investor's Education and Protection Fund Authority ["IEPFA"], Ministry of Corporate Affairs ["MCA"] has *via* intimation dated July 16, 2025 requested companies to launch a **100 days Campaign -** "Saksham Niveshak", to reach out to shareholders whose dividend and shares remain unpaid/unclaimed.

In line with this initiative and even prior to the issuance of this intimation — Colgate - Palmolive (India) Limited ["The Company"] had already taken proactive steps to assist shareholders in claiming their unpaid/unclaimed dividends. Since dividends on shares are payable only through electronic mode for shareholders with unpaid or unclaimed dividends, the amount will be credited to the shareholder's bank account only after the required information/documents are updated. Physical shareholders are requested to complete their KYC updates accordingly.

Shareholders holding shares in electronic form and have not claimed their dividend, can claim the same by updating/modifying their details with their respective Depository Participants [DPs].

The Company will in due course of time send letters as applicable mentioning details about the unpaid dividend of the shareholders along with the process for claiming the same. Shareholders are requested to approach Company/RTA to claim such dividend so as to avoid transfer of the same to IEPF authority. The Company has also uploaded unclaimed/unpaid dividends for the past seven (7) years on its website at https://www.colgateinvestors.co.in/shareholder-information/unclaimed-dividends
